

## **Terms & Conditions**

### **ELIGIBILITY**

**Either the Bride or Groom has to be a Malaysian or Permanent Resident of Malaysia. The other can be of any Nationality from any part of the world.**

**Couple must be at least 21 years old as at 17 March 2011.**

**Couple's marriage must already be or is to be registered in Malaysia.**

**> For couples who are already registered, your R.O.M must be on or after 1 January 2011.**

**> For couples who are not yet registered, your R.O.M must happen before 30 Sept 2011.**

**The actual marriage ceremony date must take place in Malaysia anytime between April 2011 and 30 Dec 2011.**
